CRIMINAL CODE OF THE RUSSIAN FEDERATION

Article 230.1. Engagement (involvement) of an athlete to usage of prohibited substances and (or) methods, which are restricted to use in sport.

1. Engagement (involvement) of an athlete by his coach, medical staff or any other specialist in a field of sport to usage of prohibited substances and (or) methods, which are restricted to use in sport, except the cases mentioned in article 230 of this Code, -

is subject for a convicted person to be fined up to three hundreds thousand of rubles or in the amount equal to wage or any other income of such person for the period up to six months with no right to occupy certain positions or to ensure some sort of activity for the period up to three years or without defined period, or be prisoned for the period up to one year with no right to ensure certain sort of activity for the period up to three years or without defined period.

- 2. The same violation made:
 - a) by the group of persons with previous conspiracy;
 - δ) with engagement of under-age athlete either two or more athletes;
 - B) by means of blackmail, violence or with a treat to its implementation, -

is subject for these persons to be fined up to five hundreds thousand rubles or in the amount equal to wage or any other income of the convicted persons for the period of one year with no right to occupy certain positions or to ensure some sort of activity for the period up to four years or without defined period, or be prisoned for the period up to two years with no right to ensure certain sort of activity for the period up to one year with no right to ensure certain sort of activity for the period up to one year with no right to ensure certain sort of activity for the period up to four years or without defined period

3. Violations prescribed in the first or second parts of this Article which lead as a consequence to a death or any other cruel consequences for an athlete, -

are subject for a person to be prisoned for the period up to three years with no right to occupy certain positions or to ensure certain sort of activity for the period up to five years or without defined period, either be forced to compulsory labour for the period up to three years with no right to occupy certain positions or to ensure certain sort of activity for the period up to five years or without defined period, or be prisoned for the period up to three years with no right to occupy certain positions or to ensure certain sort of activity for the period up to five years or without defined period.

Notice 1. Under engagement (involvement) to usage of prohibited substances and (or) methods in this Article, are meant any intended acts which result in usage of prohibited substances and (or) methods by an athlete including acts made by means of deceit, concerts, advices, directions, proposals, provision of information or prohibited substances, means of implementation of prohibited methods, removal of obstacles to use prohibited substances and (or) methods.

Article 230.2. Implementation of prohibited substances and (or) methods restricted in sport forwarded to an athlete.

1. Implementation of prohibited substances and (or) methods restricted in sport forwarded to an athlete by his coach, medical staff or any other specialist in a field of sport to usage of prohibited substances and (or) methods, which are restricted to use in sport except the cases when in compliance with the legislation of the Russian Federation in a field of sport and physical culture, the usage of such prohibited substance and (or) methods are not the cases of violation of anti-doping rules, -

is subject for a convicted person to be fined up to one million rubles or in the amount equal to wage or any other income of such person for the period up to two years with no right to occupy certain positions or to ensure some sort of activity for the period up to four years or without defined period, or be prisoned for the period up to two years with no right to ensure certain sort of activity for the period up to four years or without defined period, either be prisoned for the period up to one year with no right to ensure certain sort of activity for the period up to four years or without defined period.

2. The same violation which leads as a consequence to a death or any other cruel consequences for an athlete, -

is subject for a convicted person to be prisoned for the period up to three years with no right to occupy certain positions or to ensure certain sort of activity for the period up to five years or without defined period, either be forced to compulsory labour for the period up to three years with no right to occupy certain positions or to ensure certain sort of activity for the period up to five years or without defined period, or be prisoned for the period up to three years with no right to occupy certain positions or to ensure certain sort of activity for the period up to five years or without defined period.
